Mission Statement

The Malta Institute of Accountants (MIA) is the voice of the accountancy profession in Malta providing professional guidance, technical support and continuing professional education to over 2,400 accountants.

It is committed to attracting talented individuals to the profession and invests heavily in the process of educating prospective accountants. The Institute also helps to promote a proper understanding of the role and the value of the accountancy profession to the wider Maltese public in general and, in particular, to the local business community. The MIA forms part of leading international accounting organisations and brings the voice of the Maltese accountant to bear in these prestigious fora. It ensures that professional standards and ethics applied locally meet the requirements of international regulatory bodies and works to uphold the reputation of the profession both locally and overseas.





President's Address



This is my last address as President of the Institute. My term of the presidency is practically over and will come to an end following the 16 July 2015 Annual General Meeting. This two year term has been a very busy period for the Institute during which it has managed to carry out internal restructuring, necessary to better cope with current and future challenges, and be the focal point and catalyst to help implement legislative and other changes brought about by international developments in the European Union and the profession in general.

I want to thank, at the outset of this address, Council Members, Committee Members and the Institute's Staff for their hard work and continuous efforts to meet, sometimes, very challenging deadlines. We have all worked very hard and fortunately were able to attain results in most, though not all, of the fronts we acted on. As we keep reminding ourselves, we are the largest professional body in Malta. However, the strength of a professional body is not necessarily measured by its size, but rather by its ability to lead the profession to respond to changes, to shape public opinion on key issues, to contribute to international development and to chart new frontiers.

Over the years, MIA has been crucial to the development of the local profession and its preparation to meet future challenges. We set up and, in these past two years, continued to nourish relationships with different stakeholders that interact with our profession, to be able to influence outcomes, reach consensus where possible and provide timely training and instruction to our Members. We actively participate in the different fora established from time to time to deal with specific issues, with the more recent ones relating to the accounting transposition, audit exemptions, audit regulation and family business bill.

We continue to be active in the delivery of ongoing CPE to our Members. Also, through our joint scheme with ACCA we are involved in providing professional qualifications to students who opt to follow a part time rather than full time course in accountancy. We have a specific subsidiary entity, that is now wholly owned by the MIA, that through its exclusive association with BPP provides courses to students that lead to a professional qualification in accountancy. I am proud to announce that this entity, now to be known as AIM Professional Academy, was in 2015 appointed as a Premier Member of the BPP Global network. Through this exclusive Premier Partnership Agreement appointing us as BPP's exclusive authorised accredited partner for Malta, AIM Professional Academy takes its place as part of BPP's global network, retaining and enhancing its long-standing relationship with BPP International, continuing to rely on BPP's expertise in the delivery of high quality tuition, study materials, resources and support, thus ensuring a course experience for students that is second to none.



President's Address

We continue to value our membership in international bodies including FEE and IFAC and have endeavoured, despite our limited resources, to participate actively in the work programmes they rolled out in these past two years. Our participation in these fora is essential as it helps us be aware of the latest developments in the profession and the strategies being adopted to deal with them. We do not subscribe to the idea that all things branded foreign are necessarily better, however we did strive not to reinvent the wheel and to evaluate the relevance and adaptability of other people's ideas and processes to the local scenario. We have been involved, albeit to a lesser rather than greater extent, in shaping public opinion on key issues. This, in my view, is something that we have not done enough of and should be an area of increased focus for the Institute in an era where communication means are super easy and as a consequence misinformation rife.

There are so many issues that potentially can affect our profession, and there are so many different pieces of legislation that can have unintended consequences on us. Whilst we always encourage our Members to excel in the services they provide whether through employment or otherwise, as an Institute we have been and continue to be vigilant to see that our profession is not discriminated against or hindered from delivering its best for the benefit of the economy at large and the public interest that it serves.

International indications are that knowledge is likely to provide the foundation on which accountants can build their careers in the coming years. The significant and complex changes happening around us are pushing aside the traditional transactional and reporting areas and bringing to the fore the need for knowledge workers who can analyse and apply business information to drive decisions. Our profession excels at doing this. We possess the skill set — and education base — that allows us to understand the connectivity of complex factors. This coupled with our ability to develop a trusted advisor relationship with clients puts us in a unique position that we need to put to better use in the future. An important major event during this past year was the 50 years celebration that we had in June 2015 that was attended by the Hon Prime Minister, Dr Joseph Muscat, the Minister for Finance, Hon Prof Edward Scicluna and His Excellency, Archsbishop Emeritus Paul Cremona. The Institute has taken the opportunity to engage academics to research and recount our history in a publication that will be coming out a due course.

Another highlight for me was undoubtedly our Students' graduation ceremony. At this same event we also welcomed the university graduates as Associate Members of our Institute. All in all, over 150 students were accompanied by 300 guests for this important occasion that in essence marks the end of one milestone and the beginning of another. This year's guest speaker at the ceremony was President Emeritus, Dr Ugo Mifsud Bonnici, who spoke about the importance of values in the profession.

In all of our efforts it is key not to forget the public interest to which we have always given important consideration. I firmly believe, and I keep repeating this in various fora, that if we only serve our self-interest we will fail. Our values and ethics are essential in discharging our professional responsibilities and no efforts should be spared by the Institute to continue to make these known to our Members. Let us not forget that our reputation rides on each and every one of our 2,400 Members.

I am extremely proud of our profession and honoured to have been given the chance to serve as the President of its Institute. I trust that the hard work of all has helped to make the Institute more relevant to its Members.

Once again, I would like to thank my fellow Council Members, Committees and MIA Staff and I augur all the best to the incoming President.

The MIA held its fiftieth Annual General Meeting (AGM) at the Tower Training Centre on 3 July 2014. 181 Institute Members attended the meeting.

An election was held in which the following were elected Members of the Council for the two-year term 2014 – 2016: Fabio Axisa, Christopher Balzan, David Delicata, Anthony Doublet, Hilary Galea-Lauri, Ivan Grixti and Stephen Paris. These joined the Council Members elected in the 2013 AGM: Franco Azzopardi, Etienne Borg Cardona, Simon Flynn, Kevin Mahoney, Maria Micallef, William Spiteri Bailey and Anthony Zarb.

David Delicata, Ivan Grixti and Christopher Balzan were elected to Council for the first time.

At a subsequent meeting of the Council, Maria Micallef was elected President, Franco Azzopardi as Vice-President, William Spiteri Bailey as Secretary and Fabio Axisa as Treasurer.
